EnergyU NextGeneration Portal Release

October flew by and we still require a few tweaks before releasing NextGen. We should be announcing the date within the next couple of weeks.

EnergyU Badges

EnergyU Badges just keeps getting better! Administrators now have the ability to suspend users, suspend individual requirements for a user, and merge duplicate users. Additional reporting features have also been added.

Did you know... When using the iOS version of EZval, you may upload PEF completions directly to Badges.

PEF Uploader and Windows EZval now easier than ever

Modification of the logfile will no longer be required prior to uploading using the PEF Uploader. You may drag-and-drop the file as is without deleting columns as previously required.

FAQs

I'm new to OQ. How does EnergyU help with my OQ needs?

Learning Management – The EnergyU Learning Management System (LMS) allows you to provide your employees with access to online training and testing.

Evaluations – Paper evaluation forms are available, or use the EnergyU Electronic EZval app when conducting performance evaluations in the field. PEF completion data may be tracked, along with the training and testing data, in the LMS.

Badges – Training, testing, and evaluation data may be transferred to EnergyU Badges. An employee's badge may be scanned in the field using any QR Code reader to instantly view the status of all requirements and earned qualifications. If your company has an ISNetworld account, we can setup nightly transfers of all LMS data.



NOTE: LMS, Evaluations, and Badges may be implemented individually. For instance, you may choose to use only Badges, transferring data from your own internal LMS. You may choose to use only Evaluations, transferring PEF completion data to your own internal record keeping system. You may choose to use the LMS to deliver online training and testing, plus transfer LMS records to Badges.
